ACCESS

- PERMITTED ACCESS TO A CLIENT'S PERSONAL INFORMATION BY A THIRD PARTY
- ARE THERE DIFFERENT LEVELS OF PERMITTED ACCESS TO DIFFERENT TYPES OF CLIENT INFORMATION DEPENDING ON THE SENSITIVITY?
 - CLIENT ADDRESS AND PHONE NUMBER
 - CURRENT HOLDINGS IN THE CLIENT ACCOUNT
 - TRADING HISTORY OF THE CLIENT
 - NAMES OF PERSONS HOLDING TRADING AUTHORITY ON THE ACCOUNT

ACCESS – THIRD PARTIES

- DO SPECIFIC THIRD PARTIES HOLD A GREATER ENTITLEMENT TO A CLIENT'S INFORMATION?
 - IMMEDIATE FAMILY SPOUSE, CHILDREN, PARENTS
 - > BENEFICIARIES OF A CLIENT WILL OR TRUST ARRANGEMENT
 - OTHER SHAREHOLDERS / DIRECTORS / OFFICERS OF A CLIENT CORPORATION
 - > TRUSTEES / EXECUTORS OF AN ESTATE
 - PERSONS HOLDING TRADING AUTHORITY OVER THE ACCOUNT
 - PERSON HOLDING JOINT TENANCY WITH RIGHT OF SURVIVORSHIP
 - LAWYERS UNDER WHAT CIRCUMSTANCES?
 - **➢ GOVERNMENT CRA, FAMILY MAINTENANCE, CONSUMER AFFAIRS**
 - COURTS ONLY BY ORDER?

GENERAL REQUESTS

- WHICH REQUESTS FOR INFORMATION DOES A FIRM HAVE TO RECOGNIZE AND FULFIL?
- ARE THERE ANY REQUESTS FOR INFORMATION THAT CAN BE LEGITIMATELY DECLINED?
- IS THERE ANY INSTANCE IN WHICH YOU SHOULD DENY A CLIENT ACCESS TO THEIR OWN INFORMATION?

SPECIAL REQUESTS

- WHAT IS THE BEST WAY TO HANDLE SPECIAL SITUATIONS?
- A THIRD PARTY HAS REQUESTED ACCESS TO A CLIENT'S INFORMATION BECAUSE THE CLIENT IS:
 - ILL CLIENT IS INACCESSIBLE BY VIRTUE OF ILL HEALTH
 - INJURED CLIENT WAS IN A CAR ACCIDENT
 - > INCAPABLE CLIENT IS NOT OF SOUND MIND
 - DECEASED WHO HAS ACCESS AND WHEN IS THAT ACCESS TRIGGERED

SECURITIES COMMISSION

- WHAT IS THE CURRENT STATUS OF A SECURITIES COMMISSION DIRECTIVE TO KEEP ONE OF THEIR INVESTIGATIONS CONFIDENTIAL?
 - **FROM THE CLIENT?**
 - > FROM OTHER OFFICERS OF THE DEALER?
- HOW IS THE COMMISSION REQUEST FOR CONFIDENTIALITY RECONCILED TO THE FIRM'S OBLIGATION TO A CLIENT?

BREACH

- WHAT EXACTLY IS A BREACH?
- WHAT ARE THE MOST COMMENT BREACHES?
 - MISTAKENLY DELIVERY A CLIENT'S INFORMATION TO AN UNRELATED THIRD PARTY MAIL GETS MIXED UP
 - > PROVIDING INFORMATION TO A LAWYER THAT IMPLIES HE HAS A COURT ORDER BUT DOES NOT SENDS YOU A DRAFT ORDER THAT THE COURT HAS NOT ENDORSED
